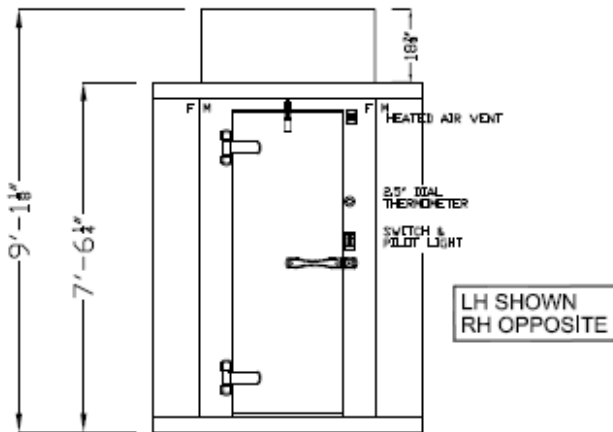
OPTION A DOOR SWING
